



Ryde Lawn Tennis and Croquet Club Privacy Policy

This Privacy Policy governs the manner in which Ryde Lawn Tennis and Croquet Club ("the Club") collects, uses, maintains and discloses information collected from members of the Club. This privacy policy applies to all products and services offered by the Club.

This document sets out how the club satisfies the processing requirements of the General Data Protection Regulations (GDPR) which comes into force in May 2018.

The club solicits the following personal data from its members:

- Name
- Address
- Phone number(s)
- Email address
- Date of birth
- Occupation

All this data is held securely on the ClubSpark database (provided by Sportslabs Technology Ltd) by the Membership Secretary for administrative purposes. Access to the ClubSpark database is password protected.

Website and Cookies

Our website uses Google Analytics.

As a member when you participate in one of our competitions, matches or events your name may be displayed on our website, which is held securely. This is an historic public record, so won't necessarily be deleted if your other personal data is deleted (the "right to erasure"). Similarly the club may, from time-to-time, publicise matches, competitions or events on Facebook when your name may be displayed. Overall, we use cookies to help us provide you with a better website, by enabling us to monitor which pages users find useful. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

- allow CA members of all the clubs you may be a member of to see your data
- allow all CA members to see your data
